



SHARON TUCH MEMORIAL SCHOLARSHIP

Since 2018, the **Sharon Tuch Memorial Scholarship** will be awarded annually to honor the memory of Sharon Tuch, the 1994 Past President of the Alamo Chapter of the American Payroll Association. During her tenure with the Alamo Chapter of the APA (ACAPA) and service on the Board of Directors prior to her untimely passing in 2017, Sharon was dedicated to the education of payroll professionals in the San Antonio area.

The purpose of the Sharon Tuch Memorial Scholarship is to recognize individuals dedicated to the Payroll Profession and encourage their educational advancement through opportunities provided in San Antonio.

SCHOLARSHIP AWARD

The Scholarship Award recipient will receive a **FREE** ACAPA membership for the **2021** membership year as well as free member attendance at all 2021 monthly educational luncheon meetings. Travel expenses to the ACAPA meeting are sole responsibility of the scholarship recipient. All meeting registrations must be completed online by the Treasurer to be processed without charge. The scholarship must be used in the following year and the recipient of this award cannot have previously won a Sharon Tuch Memorial Scholarship. Membership dues and meeting registrations are non-transferrable.

SCHOLARSHIP RECIPIENT

The recipient **MUST** be an active member in good standing of the ACAPA. Current members of the ACAPA Board of Directors are ineligible to apply. The recipient of the scholarship award need not be present to receive the award.

SCHOLARSHIP APPLICATION

An application for the scholarship must be submitted electronically no later than deadline stated on the application. Applications submitted after this date will not be considered. The scholarship application may be submitted by the individual nominee or by a third party on behalf of the nominee.

The following items must be submitted to be considered for the scholarship:

1. A completed application form due by **June 30, 2020**.
2. A completed questionnaire as shown on the application
3. One original, signed professional letter of recommendation

Applications, questionnaires and letter of recommendation should be submitted to ACAPA no later than the stated deadline.
